Dave Murray-Rust is a Lecturer in Design Informatics at the University of Edinburgh. His work is concerned with ways that people, data and things interact. Current research questions include: How can we understand the algorithmically mediated society that we are heading towards? How can we ensure that there is space for people within computational systems, preserving privacy, choice, identity and humanity while making of possibilities of computational coordination and personal data? How can we work with things that have an increasing sense of agency, from sensing, to responding, to shaping the world around them? In practice, this relates to: IoT, personal data, human data interaction, physical computing and manifesting data.

Marloes Pomp is the Initiator and Program Officer for the blockchain projects within the Dutch Government and she is responsible for the international strategy of the Blockchain Coalition. The Dutch Blockchain Coalition is a jointly developed partnership by government and knowledge industry, institutions.
